******* IMPORTANT INFORMATION *******

On 2/17/09 the FCC is requiring full power TV stations to cease broadcasting in analog and transmit in digital format. If all of your TV sets are hooked up to Mediacom this change will not affect you. If you have analog TVs that are receiving full power TV signals that are not connected to Mediacom, you may need to take action.

To continue receiving these stations, you may hook these TVs up to Mediacom for no additional charge or you can purchase a DTV converter from a local retailer. Without cable or a converter, you may have to buy a new TV. Analog TVs will continue to work for low power, class A or Translator TV stations, gaming consoles, VCRs and DVD players.

The government is offering to help subsidize the purchase of DTV converters. To apply for a subsidy program for a digital-to-analog converter box, call 1-888-DTV-2009 or visit www.dtv2009.gov.
